First Thursdays (#3.2019-2 First Thursdays): \$1,600 is to be encumbered in the Douglas Account for purposes of advertising the First Thursdays gatherings to be held over the course of Summer 2019.

Jackalope Days (#3.2019-3 Jackalope Days): \$3,617.25 is to be encumbered in the Douglas Account for purposes of advertising Jackalope Days 2019.

Kite Festival (#3.2019-4 Kite Festival): \$1,130 is to be encumbered in an even split between the Douglas and Glenrock accounts for purposes of advertising the inaugural kite festival to be held at Fort Fetterman.
